Comprehensive Joint Replacement (CJR) Collaborator Selection

Bon Secours Charity Health System, Good Samaritan (GSH) and Saint Anthony (SAC) Hospitals participates in a mandatory Medicare bundled payment initiative called Comprehensive Care for Joint Replacement (CJR) model. The CJR model aims to promote quality and financial accountability for care for Lower Extremity Joint Replacement (LEJR) procedures, commonly referred to as hip and knee replacements.

Our participation in the CJR model should not restrict your access to care, your freedom to choose your health care providers, and the quality of your care. All existing Medicare beneficiary protections continue to be available to you. This includes the ability to report concerns to Quality Improvement organizations and 1-800-MEDICARE.

As part of {GSH's}, {SAC's} participation in the CJR model, we are required by CMS to develop and maintain a written set of policies for selecting providers that share gains and risks of the program as CJR collaborators. Our criteria for selection of collaborators in the CJR model is as follows:

- The physician group, the physician and all their employees must participate in and be in “good standing” with the Medicare program and with the Medical Staff of {GSH} {SAC}.
- Selection of collaborators cannot be based directly or indirectly on the volume or value of past or anticipated referrals or business otherwise generated by the CJR collaborator.
- CJR collaborators, their employees and contractors will comply with all the CJR Model requirements including, but not limited to, requirements regarding CJR Beneficiary notifications, access to records, participation in any evaluation, monitoring, compliance and enforcement activities performed by the Hospital, CMS or its designees.

- Collaborators must sign a “Sharing Agreement” contract agreeing to adhere to the care redesign initiatives, compliance and program requirements, quality metrics and gainsharing methodologies.
- The following list includes health care providers that have entered into a collaborative agreement with {GSH} {SAC} for the CJR model.
